TERMS & CONDITIONS

ELICIBILITY

This program offer applies to Foodservice Operators only. For annual enrollment in this program operators must sign and return the BAF Powerhouse Operator Program to their BAF representative within 90 days of the start of a performance period. The enrollment form will not be binding on Basic American Foods until signed by its authorized representative.
